I, the undersigned, hereby file these Articles of Incorporation for little purpose log IDA becoming a corporation under and pursuant to the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit, and for the purpose, I hereby certify, declare, and set forth as follows, to wit:

Article I - Corporate Name

The corporation shall exist perpetually unless dissolved according to Florida law.
