In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I NAME

The name of this corporation is THOMAS E. & C. INDUSTRIES, CO.

ARTICLE II BUSINESS TO BE TRANACTED

The nature of the business to be transacted by this corporation is:

To engage in the business of providing consulting services, sales, development, and marketing.

To manufacture, purchase or otherwise acquire, and to own, mortgage, pledge, sell, *ssign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description; and

To purchase the corporate assets of any other corporation and engage in the same other character of business; and
