**ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of A Perfect Image Custom Painting Services, INC. under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is:


