ARTICLE 1 NAME

7.4 The Board of Director(s) of the Corporation may, by Restated Articles of Incorporation, classify or reclassify any uninsured stock from time to time by setting or changing the preferences, conversions or other rights, voting powers, restrictions, limitations as to dividends, qualifications, or term or conditions of redemption of the stock.

ARTICLE 8 - SHAREHOLDERS' RESTRICTIVE AGREEMENT

All of the shares of stock of this Corporation may be subject to a Shareholders' Restrictive Agreement containing numerous restrict ions on the rights of shareholders of the corporation n and transferability of the shares of stock of the Corporation. ARTICLE 9- POWERS OF CORPORATION

All references in these Articles of Incorporation to "director", "officer", "employee" and "agent" shall include the heirs, estates, executors, administrators and personal representatives of such persons.
