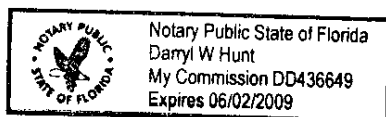
1. Ronald Cox is the President of RONALD COX HANDYMAN SERVICE COMPANY, a Florida corporation, (hereinafter "Corporation").
