CERTIFICATE OF INCORPORATION

OF

BARRERA TRANSPORT CORP.

*We, the undersigned, in order to form a Corporation for profit for the purpose hereinafter stated, under and pursuant to the provisions of the Florida Statutes, do hereby subscribe to this certificate of Incorporation, and do adopt the following Articles of Incorporation:*

ARTICLES OF INCORPORATION

ARTICLE I

*The name of the Corporation shall be:*

BARRERA TRANSPORT CORP.

ARTICLE II

*The general nature of the business and the objects and purposes to be transacted and carried on by this Corporation shall be:*

*(a) This Corporation is organized with the purpose to engage in the pick up, delivery, and transportation business and all other lawful activities permitted under the laws of the State of Florida and the United States of America.*

*b) To enter into, make and perform contracts of every kind, for any lawful purpose, without limit as to amount, with any person, firm association or corporation, town, city, country, state, territory or government.*

*c) To purchase or otherwise acquire, and to hold, own, maintain or otherwise dispose of and deal in lands and leaseholds, and any franchises, rights in real property, and personal or mixed property, and any rights, licenses*

or privileges necessary, convenient or appropriate for any of the purposes herein expressed and to have any and all powers above set forth as fully as natural person, whether as principals, agents, trustees or otherwise.

d) To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of shares of the capital stock of, or any bonds, securities or evidences of indebtedness created by any other corporation or corporations organized under the laws of the State of Florida or any other state or government, and while the owner of such stock to exercise all the rights, powers and privileges of ownership, including the rights to vote thereon.

e) To purchase, hold, sell and transfer the shares of its own capital stock; provide it shall not use its funds or property for the purchase of its own shares of capital stock except from the surplus of its assets over its liabilities including capital; and provided further that shares of its own capital stocks belonging to it shall not be voted upon directly or indirectly, nor counted as outstanding for the purpose of any stockholders quorum or votes.

f) To do all and everything necessary and proper for the accomplishment of the objectives enumerated in these Articles of Incorporation or any amendment to the Certificate of Incorporation as necessary or incidental to the protection and benefit of this Corporation and in general to carry on any lawful business necessary or incidental to the attainment of the objectives aforesaid Corporation whether or not such business is similar in nature to the objects set forth in these Articles of Incorporation and to do any all things herein before set forth the same extent as natural person might or could do.

### ARTICLE III

The maximum number of shares of stock which this corporation shall have outstanding any time shall be Five Hundred shares all of which shall be of \$1.00 par value and each of which shares shall be issued fully paid and non-assessable, and shall be payable in lawful money of the United States of America, or in service or property at just valuation, to be fixed by the Directors of this Corporation at the organizational meeting, or any other meeting held for that purpose.

ARTICLE IV

*The initial registered officer of the corporation is: FEDOR BARRERA, President-Treasurer, 1620 SW 139 Court, Miami, Florida 33175.*

ARTICLE V

*This Corporation is to have perpetual existence.*

ARTICLE VI

*The initial Post Office Address of the principal office of this corporation in the State of Florida is: 1620 SW 139 Court, Miami, Florida 33175.*

ARTICLE VII

*This Corporation shall have one directors, initially. The number of directors may be increased from time to time, by law adopted by the stockholder.*

ARTICLE VIII

*The names and post office addresses of the first Board of Directors and officers of this Corporation, who shall hold office for the first year of its existence or until successors are elected and qualified, are as follow:*

*Fedor Barrera, 1620 SW 139 Court, Miami, Florida 33175.*

ARTICLE IX

*The names and post office addresses of the subscribers to this Certificate of Incorporation and the number of shares each agrees to take and the value of the consideration paid thereof, the total aggregate amount of which is not less than the amount of capital with which the corporation will begin business, is as follows:*

*Fedor Barrera, 1620 SW 139 Court, Miami, Florida 33175. = 500 shares*

ARTICLE X

*The management and control of the business of the Corporation shall be conducted under the directions of the Board of Directors by the offices who shall be elected by the Board of Directors, to-wit: a President, one or more Vice-President, a Treasurer, and a Secretary; one or more of said officers may hold one or more offices except that the President may not also be the Secretary or Assistant Secretary. No person holding two offices shall act in or execute any instrument in the capacity of more than one office.*


ARTICLE XI

*These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a majority of the stock entitled to vote thereon.*

ARTICLE XII

*In furtherance, and not in limitation of the powers conferred by Statutes the Board of Directors is expressly authorized:*

- a) To adopt and amend the by-laws of this Corporation, provided the amendments thereto are not inconsistent with the by-laws adopted by the stockholders.*
- b) To authorize and cause to be executed mortgages and liens upon the real and personal property of this Corporation.*
- c) To set apart out of any funds of the corporation available for dividends a reserve or reserves in the manner in which it was created.*
- d) When and as authorized by the affirmative vote of stockholders of record holding stock in the Corporation entitling them to exercise at least a majority of the voting power given at stockholders' meeting duly called for that purpose, or when authorized by the written consent of stockholders of record holding stock in the corporation entitling them to exercise at least a majority of the voting power, to sell, lease, or exchange all of this property and assets, including its good will and its corporate franchises, or any property of assets essential to the business of the corporation, upon the terms and conditions as its Board of Directors deem expedient and for the best interest of the Corporation. IN WITNESS WHEREOF, the incorporators have hereunto set their respective hands and seals this 23<sup>rd</sup> day of June, 2005.*


