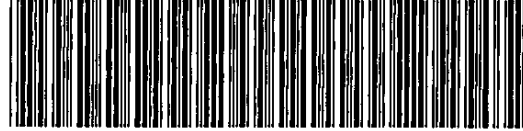

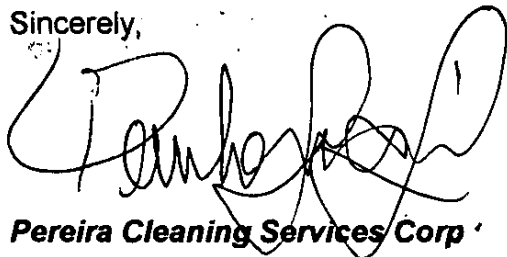
Dear Ms. Coulliette:

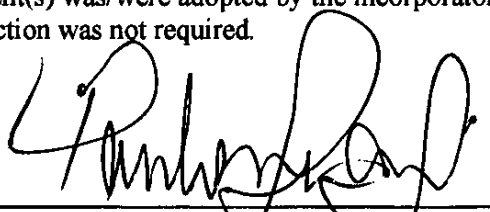
