Article I - Name

The name of this corporation is COMMUNITY INFRASTRUCTURE CONSULTING, INC., which shall have perpetual existence.

Article II - Principal Place of Business/Mailing Address

Article III - Purpose

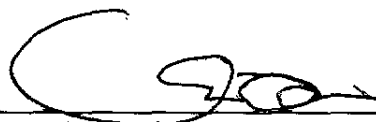
