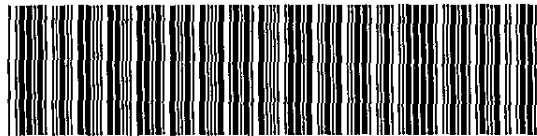

**ARTICLES OF INCORPORATION  
OF  
PEPE'S HACIENDA, INC.**

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is PEPE'S HACIENDA, INC., and the principal address and principal place of business is 10435 SOUTH WEST 45<sup>TH</sup> COURT, OCALA, FLORIDA 33476.

**ARTICLE II - REGISTERED OFFICE AND AGENT**

The address of its registered office in the State of Florida is O'CONNOR & ASSOCIATES, 1250 S. Belcher Road, Suite 160, in the City of Largo, County of Pinellas, Florida 33771. The name of its registered agent at such address is O'CONNOR & ASSOCIATES.

**ARTICLE III - PURPOSE**

ARTICLE VII - INCORPORATOR




