**ARTICLES OF INCORPORATION OF**  
**INTERAMERICAN COMMUNICATIONS GROUP INC.**  
A Florida For Profit Corporation

THE UNDERSIGNED, FOR PURPOSES OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, adopt the following Articles of Incorporation:

**ARTICLE ONE**  
NAME

The name of the corporation is Interamerican Communications Group Inc.

**ARTICLE TWO**  
DURATION

The term of existence of the corporation is perpetual.

**ARTICLE THREE**  
PURPOSE

The Corporation is formed for the purpose of engaging in any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE FOUR**  
CAPITAL STOCK

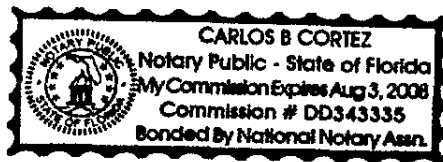
