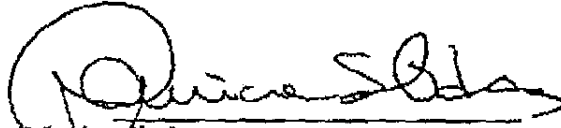

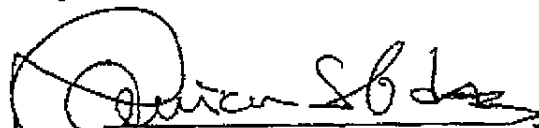
the Corporation or these Articles of Incorporation, or as may be otherwise reserved to the Board of Directors.
