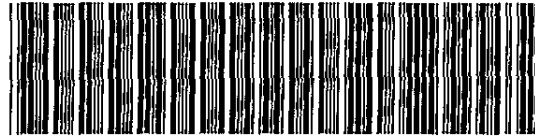

ARTICLE I - NAME

The name of this corporation is Sista Motors, Inc. (the "Corporation").

ARTICLE II - PRINCIPAL OFFICE

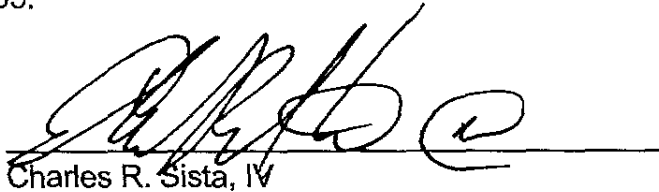
ARTICLE XI - AMENDMENT

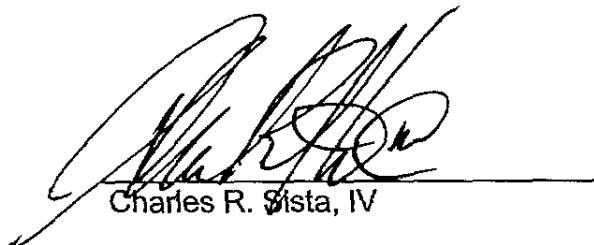
