The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: Salt Spray, Inc.
- Article 2. Address of principal office. The address of the principal office of the corporation and the mailing address of the corporation is 103 Ocean Drive, New Smyrna Beach, Florida 32169.
  - Article 3. Duration. The duration of the Corporation is perpetual.
