ARTICLE I.

CORPORATE NAME

The name of this corporation is C/T OVERSTREET TRUCKING COMPANY.

ARTICLE II.

INITIAL PRINCIPAL OFFICE

The street address and the mailing address of the initial principal office of this corporation is 4245 Apollo Avenue, Jacksonville, FL 32226.

ARTICLE III.

CAPITAL STOCK

This corporation is authorized to issue One Thousand (1,000) shares of common stock with a par value of One Cent (\$0.01) per share, which shares shall be and hereby are designated as "Common Shares." 


