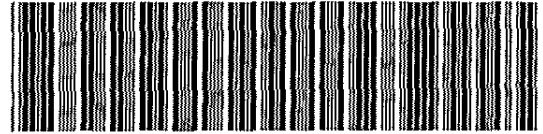

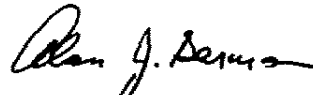

The undersigned, for the purpose of forming a professional association under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be ANTHONY M. NORRIS P.A.

ARTICLE TWO: DURATION: This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE THREE: PURPOSE: The purpose is to engage in any lawful activities or business permitted under the Laws of the United States and Florida; including but not limited to, the sale, purchase or lease of real estate.

ARTICLE FOUR: CAPITAL STOCK: The corporation is authorized to issue one hundred (100) shares, all of which shall be common shares, no par value.

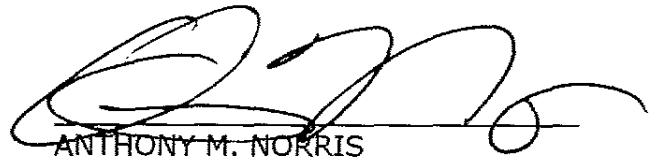

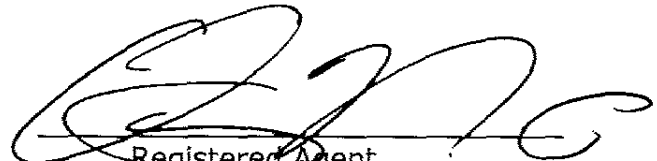
Pursuant to Chapters 48.091 and 607.0501, Florida Statutes, the following is submitted:
