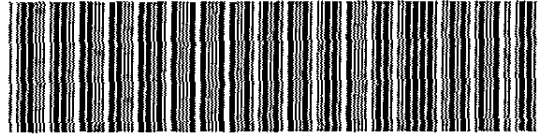


ARTICLE VI. DURATION
