ARTICLE 1-NAME

- (f) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its notes, bonds, and other obligations, and scenre any of its obligations by mortgage or pledge of all or any of its property, franchises, and income.
