ARTICLES OF INCORPORATION (PROFIT)
OF

does hereby make and acknowledge these Articles of Incorporation
under and by virtue of the laws of the State of Florida.

1. The name of the Corporation shall be: Inter DR Enterprises Corp
2. The number of shares the corporation is authorized to issue shall be 500 shares all of one class designated as common stock, at \$1.00 per value.
3. The street address and county of the initial principal office of the corporation is: 5795 SW 88th Ave. Cooper City, Fl. 33328 – Broward County and the name of the initial register agent at this address is: Diego Roper.
4. The number of the directors constituting the initial Board of Directors shall be one director and the name and address of the person who is to serve as director until the first meeting of shareholders or until their successors are elected and qualified is:

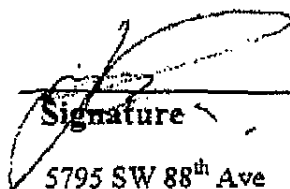
