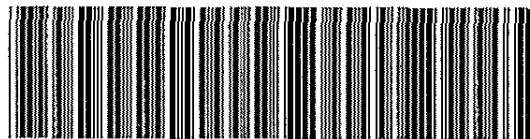

ARTICLES OF INCORPORATION

OF

135 ST. GEORGE, INC.

THE UNDERSIGNED, NANCY CLOUD, hereby executes this document for the purposes of becoming incorporated under the laws of the State of Florida, and forming a corporation under the following proposed Certificate of Incorporation:

ARTICLE I

The name of this Corporation is 135 ST. GEORGE, INC.

ARTICLE II

The general nature of the business to be transacted by the Corporation is as follows:

The Corporation may engage in any activity or business permitted by the Laws of the United States and of this State.

ARTICLE III
