The Articles of Incorporation were filed on 07/01/2005, and assigned document number P05000093832.

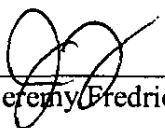
Pursuant to the provisions of Section 607.1006, Florida Statutes, this FLORIDA PROFIT CORPORATION adopts the following amendment to its Articles of Organization and its Operating Agreement:

**Article VII of the ARTICLES OF INCORPORATION AND THE OPERATING AGREEMENT OF Florida Premier Real Estate, Inc. A Florida Profit Corporation shall both be amended so that Ryan Mueller, 4444 Frances Drive, Delray Beach, Florida 33445 is removed as President and officer of the Corporation, effective October 7, 2007.**

**Article VII of the ARTICLES OF INCORPORATION AND THE OPERATING AGREEMENT OF Florida Premier Real Estate, Inc.
