We the undersigned, being competent and desirous to form a for-profit corporation under the laws of the State of Florida, having associated ourselves together for such purpose, hereby submit the following Articles of Incorporation:

ARTICLE I - NAME AND ADDRESS

Section 1. The name of this corporation shall be A1 PLUS SECURITY AND ELECTRIC, INC.

Section 2. The street address of the principal office of this corporation in the State of Florida shall be 4160 NW 21st Street, #A-150, Lauderhill, FL 33313.

ARTICLES II - TERMS OF EXISTENCE

The Corporation shall have perpetual existence, unless dissolved pursuant to law.

ARTICLE III - PURPOSE

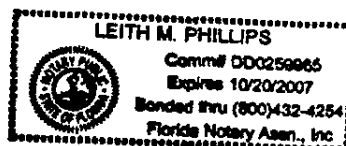
