

#### ARTICLES OF INCORPORATION

# FOR SUNCOAST BEHAVORIAL SERVICE INC.

THE NAME OF THE CORPORATION SHALL BE; SUNCOAST BEHAVORIAL SERVICE INC. 1512 POWDER RIDGE COURT, PALM HARBOR FL.34683-4640.
