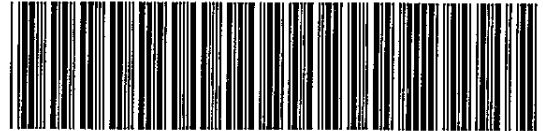

THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person competent to contract and for a corporation for profit under the laws of the State of Florida.

ARTICLE I NAME

The name of this corporation is WILSON PAUL, INC.

ARTICLE II NATURE OF BUSINESS

The corporation may engage in any activity or business permitted under the law of the United States and the State of Florida.

ARTICLE III CAPITAL STOCK

1. The number of shares of authorized capital stock of this corporation shall be five thousand (5,000) shares of common stock having no par value. The minimum amount of stated capital with which the corporation shall commence business is Five Hundred (\$500.00) Dollars.

This corporation shall indemnify and insure its officers and directors to the fullest extent permitted by law either now or hereafter.

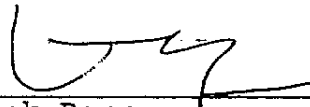

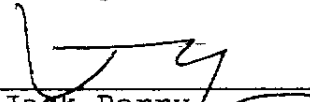

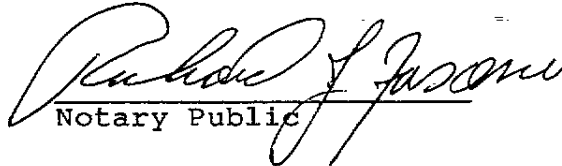
