In compliance with the requirements of F.S. Chapter 607 and 621, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: FLORIDIAN MORTGAGE GROUP, INC.

ARTICLE II

The existence of the Corporation shall begin on: July 5, 2005.

ARTICLE III

The street address of the principal office of the Corporation is: 2999 NE 191 Street, Suite PH-08, Aventura, Florida 33180.

ARTICLE IV

The specific purpose for which the Corporation is organized is: the provision of mortgage brokerage, lending and ancillary services.

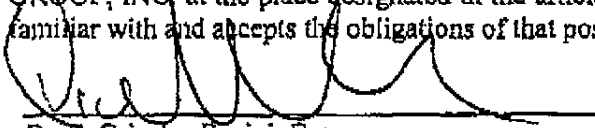
