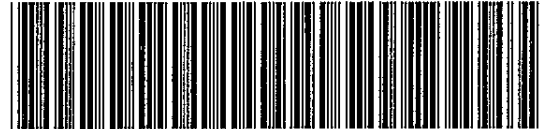

**ARTICLES OF INCORPORATION
OF
BURTOFT CUSTOM CABLE INSTALLATION, INC.**

ARTICLE I - NAME

The name of this corporation is BURTOFT CUSTOM CABLE INSTALLATION, INC.
