ARTICLES OF INCORPORATION

The undersigned hereby establishes the following for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provision of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of this Corporation shall be Integrity Roof Consultants, Inc.

ARTICLE II

<u>Purpose</u>

This Corporation is organized for the following purposes;

- (a) This Corporation may engage in roofing analysis and recommendations, materials sourcing, customer acquisition, and roofing repairs and any or all other lawful activities related thereto, and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations organized pursuant to the laws under which the corporation is organized and any and all acts amendatory thereof and supplemental thereto; and


