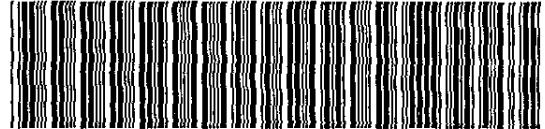



ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is CIRJO ENTERPRISES, INC. and its principal place of business shall be located at 2262 Babbitt Avenue, Orlando, FL 32833.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.


