

In compliance with the requirements of Chapter 607, Florida Statutes, The undersigned, being natural persons, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation under the Florida Business Corporation Act.

**ARTICLE I**

The name of the corporation ("corporation") is Michelle R. Bourdon, Inc.


This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the state of Florida, or any other state, country, territory, or nation.
