The undersigned subscriber, a natural person competent to contract, hereby associates himself to form a corporation under the Laws of the State of Florida, Chapter 607, and subject to the following provisions:

ARTICLE I-NAME

The name of the corporation shall be:

This corporation shall have perpetual existence commencing on the date of filing of the Articles of Incorporation.

ARTICLE III- PURPOSE
