### ARTICLE I

NAME

The name of the corporation is:

**ARTICLE II** 

### NATURE OF CORPORATE BUSINESS

To manage or administer as agent, the business or property of any corporation, firm or person in the entertainment business, and to act as agent, broker or factor of other in contracting services.
