We, the undersigned, natural persons competent to contract, hereby associate ourselves together in order to form a corporation for purposes hereinafter stated, under and pursuant to the provisions of an act of the legislature of the State of Florida, approved June 1, 1925, acts amendatory thereto, do hereby subscribe to this Certificate of Incorporation.

#### ARTICLE I

The name of this corporation shall be:

#### ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

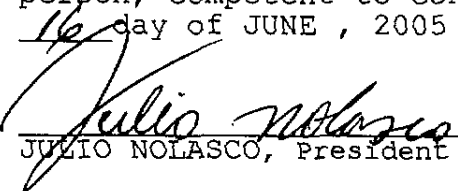

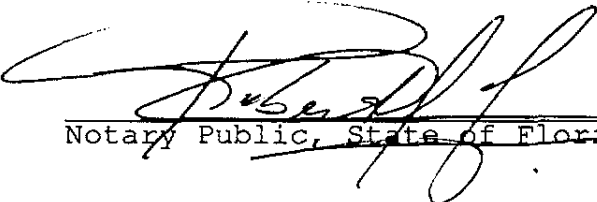

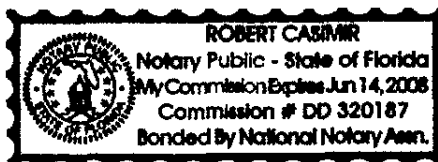
