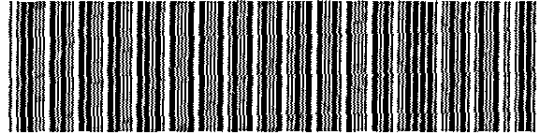



ARTICLE I - NAME

ARTICLE II - NATURE OF BUSINESS

The general nature of business to be conducted by this

commence on filing.
