**ARTICLES OF INCORPORATION
OF
RAYMOND M. MONTECALVO, M.D., P.A.**

These Articles of Incorporation are executed by the undersigned for the purpose of forming a corporation pursuant to the Florida Professional Service Corporation Act, as particularly set forth in Chapter 621 of the Florida Statutes.

**ARTICLE 1
NAME AND ADDRESS**

The name of this corporation shall be RAYMOND M. MONTECALVO, M.D., P.A. The initial principal business address of the corporation is 4323 Pond Apple Drive South, Naples, Florida 34119.

**ARTICLE 2
DURATION**

The corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.

**ARTICLE 3
PURPOSE**

This corporation may engage in each and every aspect of the general practice of medicine but only through its officers, employees, and agents who are duly licensed or otherwise legally authorized to render such professional services; and engage in any and every other activity permitted from time to time for a corporation so formed to engage in.

**ARTICLE 4
CAPITAL STRUCTURE**

The aggregate number of shares of capital stock which this corporation shall have the authority to issue shall be ten thousand (10,000) shares of common stock, all of the same class and each having a par value of One Dollar (\$1.00).


