TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006, Florida Statutes, **SYDNEY MOSES, INC.**, a Florida Profit corporation (the "Corporation"), hereby adopts the following amendments to the Corporation's Articles of Incorporation:

1. Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and is replaced by the following:

"ARTICLE I

The name of the corporation shall be:

SYDNEY MOSES, P.A., a Florida professional association (the "Corporation")."

2. Article III of the Articles of Incorporation of the Corporation is hereby deleted in its entirety and is replaced by the following:

"ARTICLE III

The purpose of the Corporation is solely to engage in the business of providing professional real estate services to the general public pursuant to the laws of the State of Florida. The Corporation shall have all of the powers vested in a Corporation organized under and existing by virtue of such laws."

The foregoing amendments were adopted by both the sole shareholder and sole director of the Corporation on August 5, 2005. The number of votes cast in favor of the foregoing amendments were sufficient for approval.
