**ARTICLES OF INCORPORATION**



The undersigned incorporator for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the Corporation is **Noah Philip Alweiss, P.A.** (The Corporation).
- SECOND: The principal office address and mailing address of the Corporation is 21077 Hamlin Drive, Boca Raton, FL 33443
- THIRD: The Corporation is authorized to issue 7,500 shares of common stock, par value \$1.00 per share.
- FOURTH: The street address of the initial registered office of the Corporation is: 21077 Hamlin Drive, Boca Raton, FL 33443, and the registered agent is Noah Philip Alweiss.



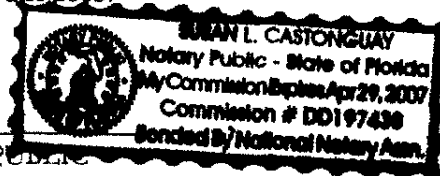
