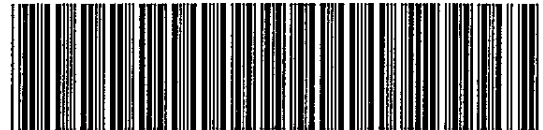

NAME OF CORPORATION**

The name of the corporation is GET JERRON SHUTTERS, INC.

**II.  
PURPOSE**

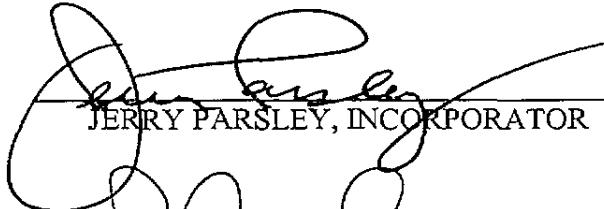

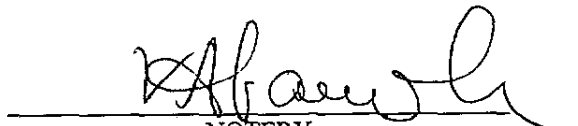
