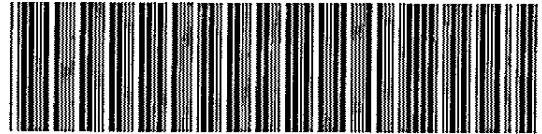

of



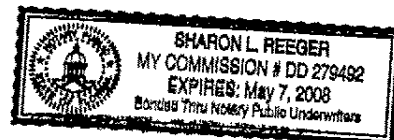
