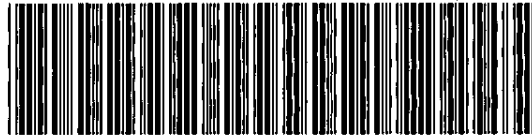

6. All the remaining property and assets of the corporation have been distributed among the shareholders in accordance with their respective rights and interests.

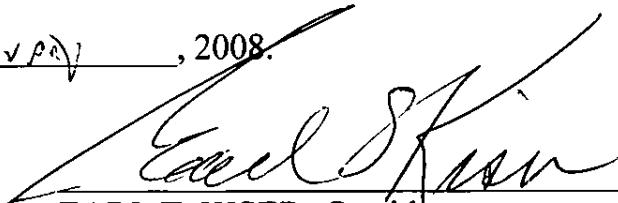
7. There are no actions pending against the corporation in any court.

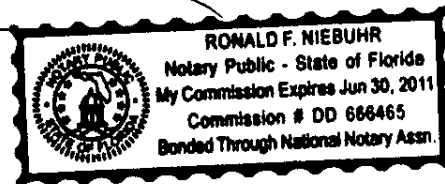
