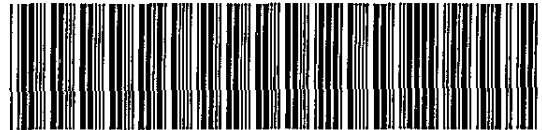

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for the profit under Florida law. SECRETARY OF STATE
TALLAHASSEE, FLORIDA

1. **NAME.** The name of the corporation is **HALF-HOUR CUSTOM AUDIO AND ACCESSORIES, INC.**

2. **TERM.** The corporation shall exist perpetually. Corporate existence shall begin when these articles are filed with the Department of State.

3. **PURPOSE.** The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

4. **CAPITAL STOCK.** This corporation is authorized to issue 100 shares of common stock of a par value of \$1.00 per share. 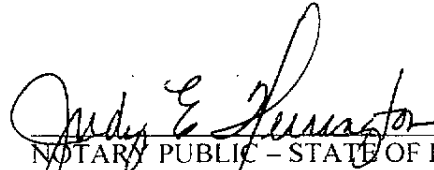

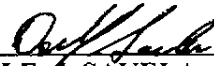
