ARTICLE I. CORPORATE NAME The name of this corporation shall be: Pacao Inc. SECRETARY OF STATE TALLAHASSEE, FLORIDA

#### ARTICLE II. NATURE OF CORPORATE BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida. The business of the Corporation shall specifically include the acquisition of ownership interest in Proalim Nicaragua, S.A. and Carlos Torres de Navarra is hereby granted full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done in and about the premises as fully, to all intents and purposes, as Pacao, Inc. might or could do it personally present, with full power of substitution and revocation, hereby ratifying and confirming all that shall lawfully do or cause to be done by virtue hereto including but not limited to the ability to purchase, sell, mortgage, encumber, transfer, gift and otherwise conduct any transaction for the acquisition of Proalim Nicaragua, S.A., a Nicaragua Company by Pacao, Inc.

#### ARTICLE III. CAPITAL STOCK
