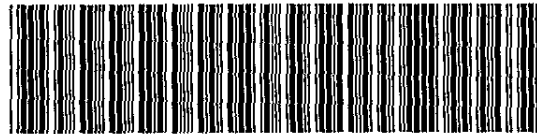

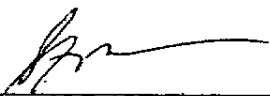
ARTICLE XI

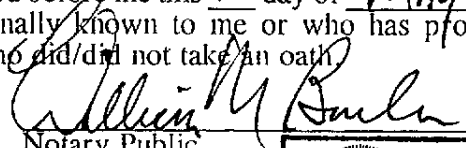

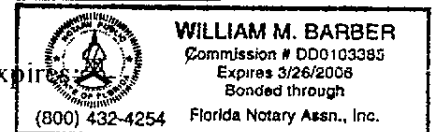

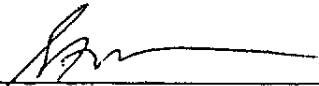
