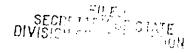

ARTICLES OF INCORPORATION OF SHARP AUTO SALES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I <u>Name</u>

The name the Company shall be SHARP AUTO SALES, INC.
