## ARTICLES OF INCORPORATION OF

## INNOVATIVE WHOLESALE FLORIST SUPPLY, INC.

#### Article I - Name

The name of this corporation is INNOVATIVE WHOLESALE FLORIST SUPPLY, INC.

## Article II - Duration

This corporation shall have perpetual existence, commencing JULY 10, 2005.

## Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

## Article IV - Capital Stock

This corporation is authorized to issue  $\underline{1,000}$  shares of common stock, with par value of \$  $\underline{1.00}$  which shall be designated "Common Shares."

## SECTION 3. Voting Rights.

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the outstanding Common Shares.
