ARTICLES OF INCORPORATION  
OF  
BATES MANUFACTURING CORPORATION

The undersigned, for the purpose of forming a corporation under Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE I

The name of the corporation is BATES MANUFACTURING CORPORATION.

ARTICLE II

The duration of the corporation is perpetual.
