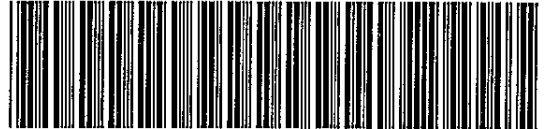



**ARTICLE I
CORPORATE NAME**

The name of this Corporation (herein "CORPORATION") shall be
