### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a Corporation of pursuant to Chapter 607, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

# ARTICLE I - NAME AND PLACE OF BUSINESS
