**ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the Corporation is Custom Rope Works, Inc. Principal place of business is 6001 S.W. 17<sup>th</sup> Court, Plantation, Florida 33317.
