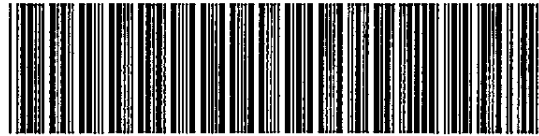

In compliance with the requirements of Chapter 607, Florida Statutes, The undersigned, being natural persons, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation under the Florida Business Corporation Act.

ARTICLE I

The name of the corporation ("corporation") is Bryan Moats, Inc.

ARTICLE II

The address of the principal office of the corporation is 8105 Colonial Village DR #207, Tampa, FL 33625. The mailing address is the same.

ARTICLE III

The maximum number of shares the corporation is authorized to issue is ten thousand (10,000) shares, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders thereof shall be entitled to one (1) vote per share on all matters on which the shareholders have the right to vote. The Board of Directors may authorize issuance of all of the corporation's shares without certificates.

ARTICLE IV

ARTICLE VII

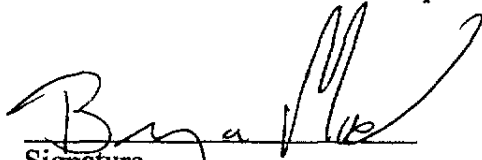
This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the state of Florida, or any other state, country, territory, or nation.
