# ARTICLES OF INCORPORATION

In compliance with Chapter 621, F.S. (Profit)

WE, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida providing for the formation of a corporation for profit, with the powers, rights, privileges and immunities hereinafter mentioned. We hereby make, subscribe, acknowledge and file these Articles of Incorporation with the Secretary of the State of Florida.

## ARTICLE I

The name of the corporation is hereinafter called: **C& L Social Services, Inc.**

## ARTICLE II

The principal office of this Corporation is to be located at: **356 S.W. Kane Ave. Port Saint Lucie, Fl. 34953.**

## ARTICLE III

The general nature of the business, it's objective and purpose is: to do any and all things allowed and permitted to be done by corporations under the Status of the State of Florida, and to do any and all of the things hereinafter mentioned as fully and to the same extent as natural persons might or could do:

- (a) To carry on and conduct a general construction, maintenance, management, personnel leasing, and accounting business.
- (b) To subscribe for, invest in, purchase or otherwise acquire, to own, hold, sell, exchange, pledge or otherwise dispose of: securities of every nature and kind, including, without limitation, all types of stocks, bonds, debentures, or obligations or evidence of indebtedness or ownership or participation issued or created by any and all associations, trusts or corporations, public or private whether created, established or organized under the law of the United States, or any of the States, or any territory or district or colony or possession thereof, or under the laws of any foreign country, foreign and domestic government and municipal obligations, or bank acceptances; to pay for the same in cash or property or by the issue of stock, bonds or notes of this Corporation or otherwise; and while owning or holding any such securities, to exercise all the rights, power and privileges of a stockholder or owner, including the right to transfer and convey the said stock or other securities to one or more persons, firms, associations or corporations subject to voting trusts to the agreements placed in such persons voting or other powers in respect of said stocks or other securities; to borrow money or otherwise obtain credit aid to secure the same by mortgaging, pledging or otherwise subjecting as security the assets of this Corporation.
- (c) To build, erect, construct, purchase, hire or otherwise acquire, own, provide, establish, maintain, hold, work, develop, sell, convey, lease, mortgage, exchange, improve and otherwise deal in and dispose of real estate and real property and all other kinds of property of whatsoever nature, whether real, personal or mixed, or any interests or rights therein without limits as to amounts; to buy, sell, assign, convey and cancel liens upon personal property and real estate of every kind and nature

whatsoever; to act as broker or agent for there purchase, sale, leasing and management of real estate, and the negotiating of loans thereon; to borrow and lend money and to negotiate loans; to draw, endorse, accept, discount and deliver bills of exchange, promissory notes, bonds, debentures, and other negotiable instruments of whatsoever nature, and secure the same by mortgage its property or, otherwise, to issue on commission, or subscribe to any government or authority, individual or corporation.

(d) To make and carry out contracts for building, erecting, improving and repairing buildings, and structures of every kind and nature whatsoever; to build, construct or repair roads, bridges, sea walls, sidewalks, ditches, drains, and in connection herein, to use an appliance or appliances, dredge or equipment of whatsoever nature; to own and operate boats, boat lines, bridges and dredge; to make, deepen or widen channels or canals; to fill in low ground; to buy, sell, manufacture, trade deal in machinery, tools, steel, iron, plaster, granite, stone, brick, lumber, shell, sand and every kind of building material and supplies whatsoever; to engage in the building and repairing of vessels, ships, boats, crafts and to do all manner of marine construction.

(e) To own, conduct, operate and maintain stores or distribution centers, warehouse, lots, storage centers or other outlets for the purpose of manufacturing, making, buying selling and otherwise dealing in building supplies and equipment incidental to the construction business.

(f) To own, buy, sell, lease, exchange or otherwise deal in real estate and personal property; to mortgage, sell and convey the same. To negotiate, purchase, hold and sell mortgage, stocks, bonds and other securities and personal property; to invest money in real estate for itself or for other parties; to build, furnish, equip, construct and repair buildings; to carry on the general contracting and constructing business; to have all powers conferred upon this corporation to carry on any business in connection with and incident of the foregoing under the laws of the State of Florida or any other State.

## ARTICLE IV

The maximum number or shares of stock with nominal par value and the maximum number of shares without nominal or par value that the corporation is authorized to have outstanding at any time, the classes, together with the distinguishing characteristics of each, into which the same are divided, and the nominal or par value of shares of stock, is 100 shares of common stock at \$5.00 par value.

## ARTICLE V

Amendments to the Articles of Incorporation shall be adopted by a majority vote of the Board of Directors at any regular or special meeting called for the purpose and proposed by the Board of Directors to the membership. A majority vote of all members present and entitled to vote at a duly constituted amend the Articles of Incorporation.
