We, the undersigned, natural persons competent to contract, hereby associate ourselves together in order to form a corporation for purposes hereinafter stated, under and pursuant to the provisions of an act of the legislature of the State of Florida, approved June 1, 1925, and the acts amendatory thereto, do hereby subscribe to this Certificate of Incorporation.

#### ARTICLE I

The name of the Corporation is:

#### ARTICLE II

#### Nature of Business

The general nature of business to be transacted by the corporation is as follows: SKIN PRODUCTS
TRAINING AND SERVICES, and to manufacture, purchase, or otherwise acquire, and to
own and mortgage, pledge, sell, assign and transfer or otherwise merchandise, other personal and real
property of every class and description whatsoever. To buy, sell, manufacture, repair, alter and
